INTERNATIONAL JETPORT NOTICE OF VIOLATION PROGRAM

Pursuant to Section 18-83 of the Portland City Code, please post this Notice and the attached Notice of Violation Program in the City Clerk's office and in the City Manager's office upon receipt. It will also be posted at the Portland International Jetport Administration Office, and on the Jetport's website. This proposed rule will take effect **fifteen (15) business** days from the date of this posting, unless otherwise ordered by the City Manager, with an effective date of **January 1, 2025**.

Written comments or objections to the proposed rule amendment must be submitted to the City Manager's office within **ten (10) business** days of the date of this posting in the City Clerk's office. Such comments should be addressed as follows:

### Portland International Jetport Notice of Violation Program

**Purpose:** The purpose of the Notice of Violation (NOV) program is to facilitate consistent adjudication of TSA, FAA, and Airport Rules and Regulations violations. The program is structured to assign points for violations and to acknowledge different levels of compliance with training, recognition of additional regulatory outcomes, and airport rules and regulations.

Based on the accumulated points an employee will have their badge(s) suspended for the associated time.

**Points**: Points are accumulated in the following manner:

<u>Initial Violation:</u> The reason for the NOV will be documented and assigned points per Appendix B.

+

<u>Compliance with Training</u>: Most violations are the result of not following the training provided. Some items are complex while others are simple. Sometimes all training is followed and still a violation occurs. Within the compliance with the training section up to one point may be credited back if the Operations Duty Officer believes circumstances warrant a relief of penalty.

-1 Point - Where in the opinion of the Operations Duty Officer circumstances warrant a relief of penalty.

<u>Airport Rules and Regulations:</u> Often violations are the result of multiple other violations. If additional Jetport rules and regulations were violated as part of the violation up to three additional points can be issued based on Appendix B.

 0 Points - No additional violations of Airport Rules and Regulations
1-3 Points - Based on additional violations of Airport Rules and Regulations per Appendix B

+

<u>Progressive Discipline:</u> With each violation by an individual it is more appropriate to further review their status as an airport badge holder. Additional Points will be issued for a second or third violation.

0 Points - First Violation

1 Point - Second Violation

2 Points - Third Violation

**Point Matrix**: Points are accumulated on a rolling two (2) year calendar. Two years after a violation its points will fall off an individual's record. The below matrix shows the point values and associated suspensions.

**First Offense Initiative:** If an individual's first offense results in 1-3 points the airport will offer in lieu of a suspension the opportunity to create a training curriculum to educate others to not make the same mistake. The individual badge holder will have the option to:

- A. Accept the 2 Day Suspension and Retraining, or;
- B. Create a training curriculum on how not to make the same mistake, and provide that training to other airport stakeholders and complete the retraining (Option B requires the approval of both the individual and their station manager/signatory).

**Negligence**: If an individual's actions are determined to be negligent by airport management, immediate badge revocation will occur.

**NOV Implementation:** When a Notice of Violation is issued it is implemented immediately unless there is a life safety/operational constraint that would negatively impact the rest of the operation. In these limited circumstances the NOV may be delayed until the end of the current shift if the Operation Duty Officer does not feel that there is a safety/security risk in allowing the individual to stay on shift.

**SELF REPORTING:** In the event a violation occurs and the individuals involved immediately self-report to the Operations Center, consideration in application of the Notice of Violation program will be given. Self reports must be made immediately and by the individuals involved in the violation.

**Appeal**: If in the course of a NOV the individual disagrees with the adjudication they have a right to appeal. Appeals must be written and submitted to the Airport Directors office within five (5) days of the NOV issuance. The Airport Director or their designee will respond to the appeal, and may hold a hearing on the matter within 10 business days of receipt of the appeal. If an appeal is requested the individual will have badge rights restored until the appeal can be heard.

# APPENDIX A NOV FORM

### Portland International Jetport Notice of Violation

NOV: You are receiving this Notice of Violation (NOV) due to your failure to follow the Jetport Rules & Regulations, Training, Procedures, Policy, and/or general Safety requirements of the Jetport or your company. Below, points have been assessed to determine the resulting penalty for your failure. Points are assessed based on four (4) criteria, including Initial Violation, Compliance with Training, Airport Rules & Regulations, and Progressive Discipline. Points are maintained on your record for a period of two (2) years and may result in increased penalties should future failures occur. Regardless of penalty, all NOV action requires the retraining in the failed category. If an individual's actions are determined to be negligent by airport management, immediate badge revocation will occur.
